NON-REFUNDABLE DEPOSIT/CANCELLATION FEE:

A \$75 deposit is required to reserve all event and single rental orders. If the rental order is canceled, the customer receives all monies paid minus the \$75 deposit. Deposits for event rentals are refunded when all items are returned by all party members listed. Deposits are deducted from individual orders and are deemed as partial payment, thus non-refundable upon tuxedo return.

We accept Visa, MasterCard, Discover, or Cash on the day of pickup. We do not accept American Express or Checks at pick up. If a rental is paid with cash, the card on file for the bride or groom of an event will be considered the primary card for that rental and will be charged for any incidentals (damage, missing items, etc).

FINAL FITTINGS:

It is highly recommended for all rental merchandise to be tried on at the time of PICK UP. Please allow 30 minutes for a final fitting and inform Black Tie and Outlet by Lori staff immediately of any issues. If customer can not be present for a final fitting and the order is picked up by another individual approved by the customer, the Black Tie and Outlet by Lori staff recommend that items be tried from home and that customers return to us for adjustments.
